Section 40 of the Act applies to this licence.

  - once when the prospective buyer first enters the internet site; (i) and (ii)
    - again, immediately before the sale of any alcohol is completed.
  - Every receipt or catalogue for the sale of alcohol sold remotely must display:
- The licensee's name (i)
- The licence number (ii)
- (iii) The date on which the licence expires.
- Any website that the licensee uses to sell alcohol remotely must display an image or a link to an image of this (f) licence.
- The whole of the premises is undesignated. (g)
- The licensed premises are more precisely identified as outlined in the plan date stamped as received by (h) Auckland Council on 1 October 2024.

# DURATION

(e)

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, this licence continues in force-

- until the close of the period for which it was last renewed; or (a)
- if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the (b) close of the period of 3 years after the period for which it was last renewed.

# This licence expires the close of 08 November 2027 unless renewed.
